### **Administrative Concerns**

Ed Lane thanked the staff for getting trees trimmed at Danny Stallings house away from the utility lines. He also commented that the Housing Authority had done a good job of cleaning up the trees along King Street in front of the Stokes Street apartments.

Archie Aples asked if we had purchased or installed anymore LED lights in town. Shoaf said we had not.

## **Continued Business**

Town Manager Brandon Shoaf gave an update on Minzie's Creek. He reported that the Council's request for more information had gone unanswered to this point. He reported that he relayed the sentiments of the board to the Minzie's Creek attorney.

Town Manager Brandon Shoaf gave an update on the Church Street Drainage. He reported that NCDOT had cleaned all the storm drain lines after a private property owner had cleaned a major ditch that most of the stormwater system flowed to.

Town Manager Brandon Shoaf gave an update electric rate study and said he's still hopeful that UFS will have information for the Council in April.

Town Manager, Brandon Shoaf gave update on the FEMA work from Hurricane Matthew and reported that we have been assigned a new representative again. He and the Police Chief had met with the new rep, her superior and a mitigation manager last week, but wasn't sure when we may meet again and get the process finished.

Motion by Sid Eley and seconded by Horace Reid, and passed 4-0 to set a public hearing on April 10, 2017 for changing the utility deposits police to an amount capped at \$450.

The Town Manager presented a copy of estimate to bring the bathroom in the Municipal building into ADA compliance for the NCDMV and said he'd bring back more information as soon as possible.

Mayor Pro Tem Lillian Holman presented the ABC report showing a decrease of 4.13% over last February.

Town Manager Shoaf presented a reimbursement request from Phillip Lane for the capacity fees he paid during construction of his new home.
